



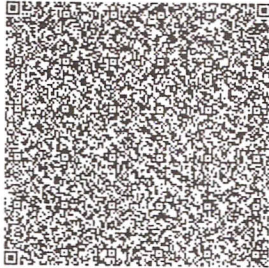

- 1 That I am the Director in the above company/firm and as such am well conversant with the functioning of the company/firm(as the case may be) and state on oath.





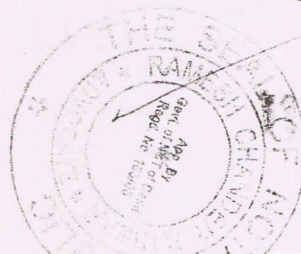
