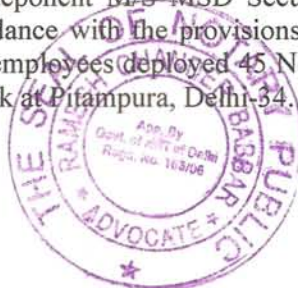

- 8 That the process work on which the contract workers are to be deployed are no abolished by the Authority or Board.


